- 4. AGSA shall have the right to withhold payment of any royalty or fee to any entrant.
- 5. AGSA shall have the right to record, televise, photograph, film or tape any entrant's performance in all stages of the competition.
- 6. The Council of the Guild shall decide the order of performance.
- 7. The competition is open to all pianists, 36 years and under on the date of the final.
- 8. Original music must be sighted by the judges and appropriate copyright rules must be followed if copies are used.
- If not an Australian citizen a statutory declaration indicating Australian residency of a minimum of two years before the date of the Final is required.
- 10. The competitors are responsible for providing their own singers and/or instrumentalists. The Guild will provide the soloist for the set work.
- 11. Previous winners may not enter the Award again.



CONTENT FOR AUDITION

1. Prepared Items (approx. 10 mins)

The competitor, with associated artist(s), should present two contrasting works by different composers for piano and voice and/or instrument(s).

Guidelines for choice of works:

- suitable for recital & broadcast
- demonstrate advanced technical, ensemble and interpretative skills
- · single movements are acceptable
- · the majority written for keyboard
- one chamber music item beyond duo is acceptable (3 to 6 musicians)
- · one orchestral reduction is acceptable

Set Work Robert Schumann's Fantasiestücke numbers 1 and 3.

A short rehearsal (approx. 15 mins) will be arranged for finalists in the venue on the day before, with the guest soloist cellist *Janis Laurs*.

The Set Work must be included in the Final.

3. Quick Study (approx. 5 mins)

Competitors will have two weeks to prepare (accompaniment only) of a work emailed to them by MONDAY JULY 12 as part of the audition process.

Robert Schumann's *Fantasiestücke* numbers 1 and 3 A short rehearsal (approx.15 mins) will be arranged for finalists in the venue on the day before, with the guest soloist, cellist JANIS LAURS. The Set Work must be included in the Final.
